- From early August through October, the program will include weekly materials for review, along with a combination of in-person sessions and online instruction via Zoom and recorded videos from past programs. Final oral exams will be conducted either online or in person.

- Each week will include in-person activities (labs) offered at various times during the week and weekend, or structured to be completed independently. You're welcome to choose the option that works best for you, but we highly encourage you to attend at least one of the three labs each week.
- Three opportunities for either in-person or online orientation will be offered at the beginning of the program, on or around August 1, 2026. The graduation ceremony will be held on the evening of Saturday, October 31, 2026 (or a date soon after), from 6:00 to 8:00 pm. Participation in both events is required.
- Completion of each section of the training is dependent on successfully completing an on-line quiz covering the week's material.
